- 3. Have imported the food(s) listed in **ANNEX 2** for **PERSONAL CONSUMPTION** only (as per item 1.3 above) and such foods are not intended for sale or advertisement / or as tester / or a commercial sample.
- 4. Acknowledge and fully understand that in order to sell or advertise any imported food products, all requirements in the Public Health (Food) Act (Chapter 182) and its Regulations must be complied with; and this shall include submission to the Brunei Darussalam Food Authority (BDFA) for registration of the said food product and its subsequent registration approval. Existing national requirements by the Royal Excise and Customs Department to declare all commercial imports will also need to be adhered to.
- 5. Will apply for registration of a food product at the BDFA, should I decide to import the food product for sale to the public, for reasons other than for personal use.
- 6. Acknowledge the authority of Food Officers as gazetted under the Public Health Food Act (Chapter 182) and its regulations, and will not intervene or obstruct a Food Officer in the course or execution of their duties; which includes:
  - 6.1. Select, demand or take samples of any imported food for analysis without any payment;
  - 6.2. The right to stop, search or detain any vehicle or conveyance of food and take samples, should the imported consignment be inspected at any point(s) of entry into Brunei Darussalam;
  - 6.3. Examine, make copies or take any books, documents or other records which contains any information relevant to the enforcement of the Public Food Act (Chapter 182) and its Regulations;
  - 6.4. Seize or detain any food or appliance which may contravene any provisions contained therein the Public Food Act (Chapter 182) and its Regulations;

Understand and acknowledge that if I do anything in contravention of the Terms & Conditions as stated in this form, I may be liable to be prosecuted under the Public Health (Food) Act (Chapter 182) which may result in punishment of imprisonment, or
